
**Submittal of County Growth Plan

Whereas, the Obion County Coordinating Committee has submitted a County Growth Plan for Obion County and its municipalities; and


Whereas, the Coordinating Committee has certified that the plan has been ratified pursuant to TCA 6-58-104;


