
SUBMITTAL OF COUNTY GROWTH PLAN



Whereas, the Washington County Coordinating Committee has submitted a County Growth Plan for Washington County and its municipalities; and


Whereas, the Coordinating Committee has certified that the plan has been ratified pursuant to TCA 6-58-104;
